Corona Virus Disease 2019, abbreviated as Covid-19, has become endemic in the world, including Indonesia. The Indonesian government has issued a policy to close all places of social activity such as places of worship, restricted shopping centers, and closed schools and colleges. With the implementation of this policy, school and tertiary education activities use alternative online education services (in the network). Education services are diverted to their respective homes using electronic media facilities with video call programs, WAG, and the like which require the assistance of parents and teachers using health standards according to WHO references, namely: washing hands with soap, wearing masks, using hand sanitation, keep your distance and then follow it with an appeal to avoid crowds in markets, malls, parties ups and downs, and travel less.

This condition has been in effect in Indonesia since March 2020 until now. Millions of people have been confirmed positive for Covid-19, and this has had a psychological and sociological impact on them. This research has studied their psychological and sociological conditions. It is said so because this type of disease kills humans in a relatively short time and this is frightening for the government and all levels of society. Various information via electronic media reporting developments in the death toll caused by the outbreak of this virus from time to time by the team at the national level Covid-19 virus control posts is increasing concern about the threat to people's lives. Rural and urban communities are increasingly anxious and increasingly afraid of the events that are currently experiencing so that every resident who is detected as reactive and is isolated either in the hospital or in their respective homes becomes a source of community conversation and all members of the community know and avoid it. Against this condition, people are increasingly complying with government regulations and invitations to comply with health protocols based on WHO health standards, namely: washing hands with soap and running water, wearing masks, keeping a safe distance, and avoiding crowds, and limiting activities outside the home if it's not urgent...

For people who have been confirmed positive for Covid-19, apart from having a great sense of fear of the threat of death since the appointment of a Covid-19 patient until the recovery period through self-isolation (isoman), these patients are psychologically and sociologically disturbed and need trauma recovery within a certain time. What is the condition of the psychological impact and sociological impact of the community positively affected by Covid-19, it is necessary to study and find alternative solutions to solve the problem, especially in the context of post-Covid-19 community economic development.

Conceptually, the World Health Organization (WHO) stipulates that Corona Virus Deterse 2019, abbreviated as Covid-19, has become a pandemic because this virus has spread to various countries and even worldwide. WHO defines a pandemic as a condition in which the world's population has the potential to fall and become ill, resulting in sudden death. The spread of Covid-19 can be spread in two ways, namely through contact and droplets and through formal transmission or surfaces of objects contaminated with the virus.

1. Spread via Contact and Droplets

Transmission of SARS-CoV-2 can occur through direct or indirect contact. Direct contact can occur if we have close contact with an infected person, either through secretions such as saliva, respiratory tract secretions such as coughing, sneezing and talking. Meanwhile, indirect contact can occur if we accidentally touch objects around which have been contaminated with the virus, while droplet transmission can occur if we are within a distance of less than one meter from an infected person or a person who has symptoms of coughing and sneezing. These droplets can reach the mouth, nose and eyes of people who are susceptible and infected (RI Ministry of Health, 2020).

2). Deployment via Formit Transmission

Respiratory tract secretions or droplets released by an infected person can contaminate surfaces and objects, resulting in formit (contaminated surface) formation. Viruses and/or SARS-CoV-2 that are alive and detected through RTPCR can be found on these surfaces for hours to days, depending on the surrounding environment (including temperature and humidity) and the type of surface (Ministry of Health RI, 2020)

3. Psychological Impact on the Covid-19 Virus

Bender L. (2020), stated that the threat of Corona virus transmission can change human psychological responses to ordinary interactions, making humans behave in unexpected ways. Radio and television programs spreading the word about the latest death tolls, with frightening statistics can generate increased anxiety that has a direct impact on our mental health, and this requires some behavioral immunity. This is the case with Anhari (2020), who stated that we need to develop a series of psychological responses to make behavioral immunity the first line of defense to reduce our contact with others who may be contaminated with the virus. 4. Sociological Impact on the Covid-19 Virus

Hartono (2012) argues that because humans are a social species that evolved to live in large groups, the behavioral immune system also modifies human interactions with each other to minimize the spread of disease, which leads to external social distancing. This response is quite heavy because since human ancestors never had an understanding of the specific causes of each disease and how it is transmitted. Because of this, according to him, the social impact of the Covid-19 virus "maintaining and increasing behavioral immunity by adhering to the principle "it is better to be safe than sorry" is an alternative solution to minimize understanding of the concept of shifting social interactions due to the Covid-19 virus. To overcome this, a special strategy is needed in efforts to implement the stages of development, specifically the stages of the people's economic development process to restore national economic conditions after Covid-19.

B. Profile of Weak Economic Community Conditions in the Covid-19 Era

Since the outbreak of information about Covid-19, it's not only the government that has experienced tension in its efforts to deal with and overcome the conditions of government control and economic and community life, but also the public is increasingly confused by the torrent of information on the threat to the life of this deadly virus, Covid-19. People's economic development essentially encourages people's economic growth in all business sectors by using strategic approaches so that various programs can be implemented optimally. In development theory known as the theory of community development (*Community Development*). Community development is the basis as well as the main capital for national development. When the community has human resource capabilities produced by community development efforts, it is assumed that the subsequent development process will further facilitate the achievement of community development goals. To carry out community development, what must first be built is a Community *Organization*. How is the form and process of organizing society, carried out through the formation of social organizations in people's lives. These social organizations include among others; Rukun Tetangga, Rukur Warga, religious organization groups, village cooperatives, and family organizations which presumably can be used as a means of developing village communities through social activities, counseling, livelihood education and the like.

These groups are then developed to become a bridge to increase the growth and development of cooperative-based community-based economic enterprises and the needs of community members as group members. This is in line with Suzane Kindervatter's view that is known as *the Empowering Process*, namely the process of strengthening community potentials by means of grouping people in a limited way based on their needs and potential while at the same time carrying out collaborative integrated planning to determine and establish work programs and carry them out together to achieve goals. together. (Wullur, 2022).

After the formation of organized community groups, the next step is the educational transformation process using the *Andradogy approach* so that there is an internalized awareness for learning. This internalized awareness can occur when learning needs come into direct contact with the needs of their lives. This concept is in line with the views of James Botkin, (1984) with the concept of learning without knowing a time limit (*no limit to learning*). He emphasized that learning without knowing the time limit should refer to the innovative learning concept of innovative *learning* which examines anticipatory learning *and* participatory learning. Innovative learning means that what is to be learned is more oriented towards the latest information to acquire the latest knowledge and skills. To realize this innovative learning requires the concept of anticipatory learning, namely being able to predict conditions that will occur in the future based on data and facts that are current in the field. In addition to this, after discovering concepts and solutions for action, a determination and commitment by the community and learning residents are needed to execute them in the form of concrete actions in the field (Wullur, 2022: 99).

The strategy for implementing post-Covid-19 populist economic development is to re-condition the socio-economic conditions of weak economic communities by taking the following steps:

- 1. Mapping the business potential and needs of weak economic communities in line with the business potential and resources, both natural and human resources, as well as available financial resources.
- 2. Analyze the intended potential to be prioritized in accordance with the stages of development of regional, national and global economic conditions.
- 3. Execute program decisions to be carried out in stages: (1) determine the type of program, program objectives, (2). Recruitment of program participants and recruitment of learning resources, (3). Allocation of funds and implementation time, and (4) action activities accompanied by monitoring and evaluation of their implementation.

4. Establish program implementing groups by collaborating with social organizations that grow in people's lives to jointly plan operational activities so that they are right on target, the right activities and can take place efficiently and effectively.

Closing

Covid-19 has hit the world including Indonesia. Various experiences have become lessons for mankind that vigilance is the main reference regarding personal and environmental health, readiness to anticipate all possibilities by means of readiness to live in the new normal era which is marked by carrying out measured routine activities, planning and carrying out activities that are more productive in nature, distance themselves from consumptive lifestyles, and orderly management of life.

Thus the development of the people's economy is more of an approach centered on weak economic communities to encourage and trigger a spirit of business through the concept of livelihood education using the entrepreneurship approach.
